

Streamio Terms of services

Registration & accounts

To use Streamio you must register for a user account by providing full and correct user information as requested in the registration process. Using your real name an e-mail adress is a requirement. Account names are free form - use your company name, product or whatever you like. Names may not include Streamio or any other trademarks owned by Rackfish, and may not be obscene or questionable by common moral standards.

Account security

Users may not allow others to access their user account, all users that needs to access Streamio must have a personal account. It is possible to invite more users to the same video account and the same user account can access several video accounts.

Streamio Test subscription

Accounts will need renewal every 30 days. We will alert via e-mail when renewal opens up for your account. Lack of renewal leads to freezing of the account, which also is alerted via e-mail. A frozen account will be deleted after a grace period. We do not allow test accounts that is used commercially in a way where viewers are paying for content, such as pay-walled or pay-per-view content. Contact us if you need to develop such functionality and wants to use a test account during development.

Streamio's paid accounts does not require renewal and may be used for payed content.

Content restriction

You may not use Streamio in any way for content that:

- Violates third party rights
- Violates laws
- Is hateful for discriminatory
- Depicts violence or cruelty towards people or animals
- Is pornographic
- Promotes pyramid-, MLM or dubious business schemes
- · Exploits minors

Content rights, Warranties and Indemnification

User guarantees holding the rights to submit any content uploaded to Streamio and will pay any

third party royalties needed in doing so. User also guarantee that the content does not infringe any third party's rights and that it complies with this agreement.

User will indemnify, hold harmless and defend Streamio and Rackfish AB as well as our suppliers, resellers, employees, directors and officers from and against all third party actions that:

- arise from activities on Streamio
- Follows a violation by you of any term of this Agreement
- Follows that content submitted violates any law or in third party right

The rights to the content is not affected by it being uploaded to Streamio. By uploading content you give us the right to distribute the content via links and through our CDN. Deleting content does not guarantee an immediate, world-wide removal of the content.

Termination and account deletion

Deleted content cannot be restored and the links to movies are deactivated and cannot be reclaimed. Streamio may also remove any content that is in breach of this contract or in some way is affecting our reputation.

Streamio is a registered trademark by Rackfish AB, Sweden. This agreement is governed by the laws of Sweden. In case of dispute parties should make efforts to resolve the dispute by mutual agreement. If no agreement can be reached the dispute should be brought before Uppsala district court as the first instance under Swedish law.
