Streamio is a free subtitling service provided by Rackfish AB ("we," "us," "our"). The service allows users to upload video content and receive automated subtitles and transcriptions.

### 2. Acceptance of Terms

By using our service, you ("user," "you") agree to these Terms of Service and confirm that you have read and understood them. These terms are governed by Swedish law and comply with the General Data Protection Regulation (GDPR).

## 3. Content Requirements and Restrictions

- Flagged for analysis
- · Reported to relevant authorities
- Retained for investigation purposes as legally required

#### 4. Service Provision

#### 4.1 Free Service

- This service is provided free of charge.
- We provide no guarantees regarding service availability, accuracy, or performance.
- Service may be interrupted or discontinued at any time without notice.

#### 4.2 Technical Infrastructure

- · Service is provided exclusively using equipment owned by Rackfish AB.
- All processing occurs in our own datacenters within Sweden.
- We do not use third-party cloud providers from countries with inadequate privacy protections.

### 5. Marketing Communications and Consent

#### 5.1 Marketing Email Agreement

By using our free service, you agree to receive marketing emails from us. This agreement serves dual purposes under Swedish law:

## 6.3 Data Sharing and Third-Party Access

- We will not share your data with any third parties
- All data processing is conducted exclusively by Rackfish AB personnel
- No external service providers have access to your personal data or uploaded content

#### 7. Data Retention and Deletion

#### 7.1 Automatic Deletion

Uploaded videos and generated subtitles are automatically deleted upon completion of transcription within 24 hours of processing completion from the subtitling system. For urgent removal, contact <a href="mailto:support@rackfish.com">support@rackfish.com</a>.

- We will process removal requests as quickly as technically feasible

### 7.3 Legal Retention

- · Required for reporting to authorities
- Subject to legal preservation obligations

You have the right to:

- · Access your personal data

- Request erasure of your data
- · Restrict data processing
- · Object to data processing
- Data portability
- · Withdraw consent at any time
- Lodge complaints with the Swedish Authority for Privacy Protection (IMY)
